**SECTION I : INVITATION FOR BID**

**Subject : INVITATION OF BIDS FOR EMPANELMENT OF FIRMS FOR PROVIDING SERVICES TO INDIAN SHIPS IN ALL PORTS OF THE UNITED ARAB EMIRATES.**

The Embassy of India (Eoi), Abu Dhabi invites sealed bid for empanelment of firms for providing services to Indian Ships in all ports of the United Arab Emirates. Bids are invited from reputed and experienced firms having registered office in UAE for providing services to Indian Naval Ship as per the details but not limited to the services as mentioned in Section-II of the bid document.

The bids, containing these documents should be submitted in a sealed cover, superscripted ***“Bid for empanelment of firms for providing services to Indian Ships in all ports of the United Arab Emirates”*** and addressed to the 'Head of Chancery, Embassy of India, at Plot No. 10, Sector W-59/02, Diplomatic Area, Off the Airport Road, Abu Dhabi, UAE. The bid must reach the above address on or before 17 November 2023 by 11.00 hrs. Bids may be hand delivered or send by post at the aforementioned address so as to reach on or before the prescribed date and time. Embassy will not be responsible for any postal delay.

3. The Embassy reserves the right to amend any of the terms and conditions contained in the Bid Document or reject any or all applications/offers without giving any notice or assigning any reason thereof. The decision of the Embassy in this regard will be final and binding upon all the bidders.

**SECTION II : TERMS AND CONDITIONS**

1. The Bid shall be neatly arranged, plain and intelligible. Each page of the Bid should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.
2. The Bidders shall submit documentary evidence in respect of their technical capabilities.
3. At any time prior to the deadline for submission of bids, the Embassy may, for any reason, whether on its own initiative or in response to the clarification requested by a prospective bidder, modify the bid document.
4. Bids shall be valid for 90 days from the date of submission. A bid valid for a shorter period shall stand rejected.
5. Any bid received after the deadline for submission will not be accepted.
6. In case of any ambiguity/ dispute in the interpretation of any of the clauses in this Bid Document, Embassy's interpretation of the clauses shall be final and binding on all parties.
7. Selected companies will be empanelled with the Embassy for provision of services to Indian Ships in all ports of the UAE.
8. Embassy reserves the right to terminate the empanelment at any point of time, if the services are not found satisfactory. Decision of the Embassy in this regard shall be final and binding upon the contractor.

**SECTION III: SERVICES REQUIRED**

1. The bidders will be required to provide the following Ship Husbanding Services during the visits of Indian Ships to UAE:-

(a) Port Services including:-

- (i) Pilotage (per pilot)
- (ii) Tugs (Bollard Pull of sufficient capacity)
- (iii) Line Handling
- (iv) Mooring Boat
- (v) Berthing/ unberthing assistance
- (vi) Payment of Port Dues
- (vii) Payment of Other Levies

(b) Harbour Facilities including:-

- (i) Electricity (per MW Capacity)
- (ii) Fresh Water (per Ton)
- (iii) Garbage/ Rubbish Removal – Once Daily.
- (iv) Sewage Removal
- (v) Sullage Removal. Discharge hose of suitable length alongwith end fitting may be provided by the sullage barge/ Truck.
- (v) Fenders (YOKOHAMA – Large Size)
- (vi) Crane Hire
- (vii) Brow
- (viii) Gangway (greater than 30 feet)
- (ix) Newspaper English (20 per day)/ Magazines (05 per day)

(c) Telephone/Internet on daily rental basis.

- (i) Sim Cards (with ISD and India calling activated and sufficient recharge coupons)
- (ii) Wi-Fi routers (25 GB data each daily)

(d) Clearance of items at airport/ sea port, if required.

(e) Fresh Provisions as per requirements.

(f) Transport Facilities:-

- (i) Sedan Car on Daily Basis.
- (ii) SUV on Daily Basis.
- (iii) 18-26 Seater Van/ Bus on Daily Basis.
- (iv) 48-52 Seater Bus on Daily Basis.

(g) Supply of Fuel [High Flash High Speed Diesel – HFHSD (MIL-DTL16884M or NATO F-76) at the concerned port. The Supplier will be required to produce a certificate from a Certified Laboratory specifying the Sulphur content and samples will also be tested onboard prior to acceptance.

  - (a) Profile of the company including net-worth and annual turnover.
  - (b) List of works undertaken by the company during last 03 years. Work undertaken for Diplomatic Missions should be mentioned separately.

  - (d) Organisational structure of the company with break up of different nationalities employed in the UAE.
