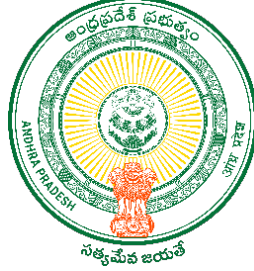

### 2. Introduction and Background

**Andhra Pradesh**, a leading maritime state in India, boasts a coastline stretching approximately 1,053 km—. Nestled along the eastern seaboard, this coastal gem holds immense promise for economic growth and development. The **Andhra Pradesh Maritime Board (APMB)**, established by the Government of Andhra Pradesh, is at the forefront of harnessing this potential.

Andhra Pradesh is Ranked 1<sup>st</sup> in inland fish production and 4<sup>th</sup> in Marine production. Andhra Pradesh has a potential of 2.1 million metric tonnes of Marine fisheries, out of which Andhra Pradesh is currently utilizing 28% of the potential.

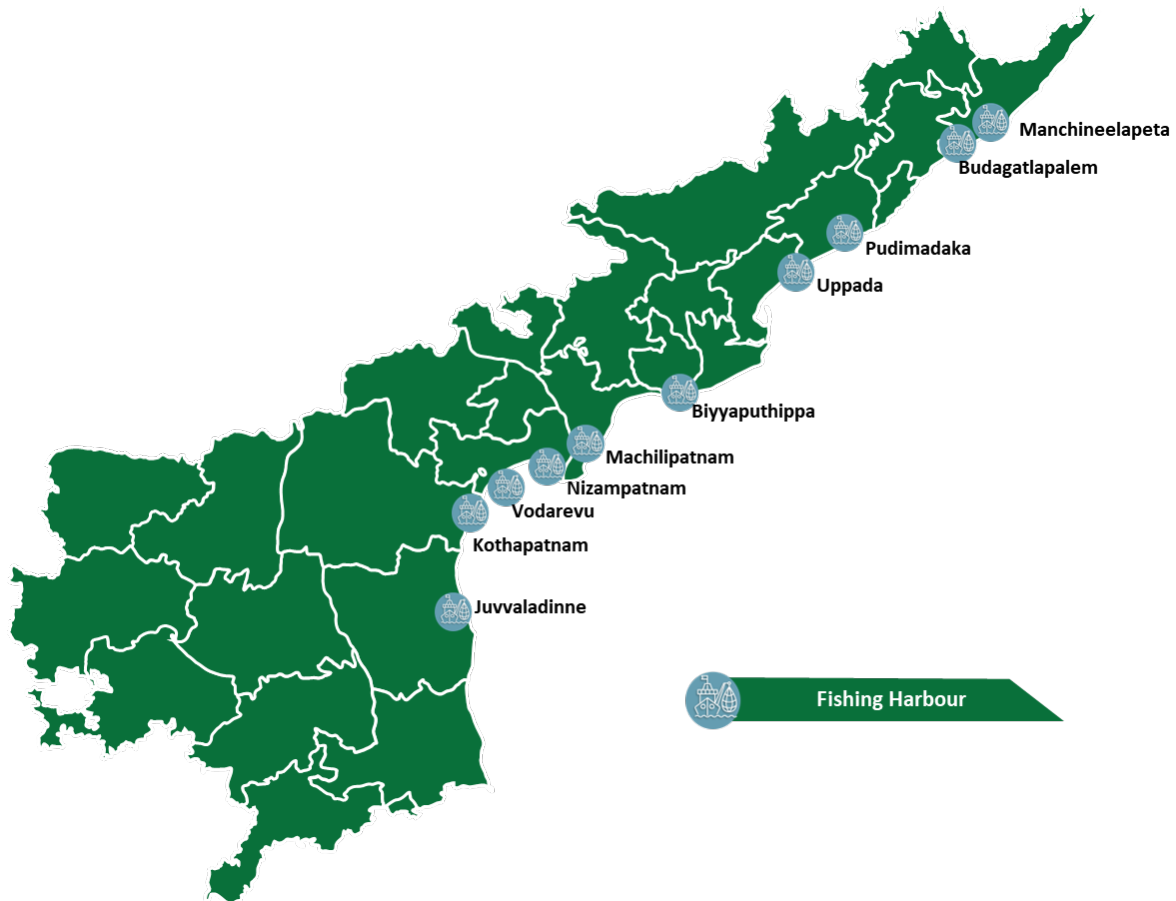


Figure: Location of Fishing Harbours being developed in Andhra Pradesh

### 3. Development of Fishing Harbours

**Andhra Pradesh Maritime Board (APMB)** has identified the untapped potential in the marine fisheries and planned for the development of 10 Modern fishing harbours in two phases. Phase-I consists of Juvvaladinne in Nellore district, Uppada in Kakinada district, Nizampatnam in Bapatla district, Machilipatnam in Krishna district, Phase-II consists of Budagatlapalem in Srikakulam district, Pudimadaka in Ankapalle district, Kothapatnam in Praksham district, Vodarevu in Bapatla District, and Biyyaputippa in West Godavari district.

## 4. Instructions to applicants

The EOI encourages applicants to propose innovative and comprehensive solutions that enhance the fishing industry's infrastructure, promote economic growth, and uplift the fishing communities in Andhra Pradesh.

### 4.1. Scope of Proposals:

This EOI welcomes a wide array of proposals from interested parties, encompassing the following areas:

- Operation and Maintenance of Fishing Harbours:
  - Efficient management and upkeep of existing fishing harbour facilities.
  - Implementation of modern technologies and practices for harbour operations.
  - Ensuring the safety and security of harbour users and vessels.
- Development of Cold Chain Infrastructure:
  - Construction and operation of processing plants, ice plants, and packaging facilities.
  - Establishment of cold storage facilities to preserve the quality and freshness of the catch.
  - Creation of value-addition units to enhance product offerings and market reach.
- Development of Auxiliary Industries:
  - Establishment of fuel stations to cater to the needs of fishing vessels.
  - Setting up of boat building and repair yards to support the fishing fleet.

- **Community Development:** Explore projects to enhance the socio-economic well-being of fishing communities.
- **Market Linkages:** Develop strategies to connect fishermen with buyers, processors, and exporters.
- **Technology Integration:** Propose technology solutions to improve traceability, data management, and efficiency in the fishing industry.

#### **4.8. Amendment of EOI Document**

#### **4.9. APMB's Right to Terminate the EOI Process**
